Charter Transport Agreement

This agreement is between - hiring customer(s)

_____ and Belle Amie Pty Ltd trading as Belle Classic for the documented vehicles at the times indicated and subject to the following conditions:

- A booking deposit of \$100 per vehicle is required to reserve the vehicles.**
The booking deposit is non-refundable and is deducted from the total cost. A tax invoice will be issued at the time of booking noting deposit paid. An updated invoice is issued for payment four weeks prior to your charter if relevant.
- The balance of the account is to be paid prior to the charter day or cash in advance to the driver on the day.**
Payment may be by cheque, cash or electronic funds transfer (account details below).
- Hire agreements can only be made by an adult 18 years of age or over.**
The hiring customer will be held responsible for the conduct of all passengers within their party. Belle Classic reserves the right to terminate the charter agreement without refund if passengers become unruly or abusive.
- All vehicles are non-smoking by law.** Should this condition be ignored the drivers are instructed to terminate the charter agreement.
- All passengers are required to wear seat belts in accordance with current laws (where fitted).**
Many classic cars are not required to have seat belts fitted. Be advised that some Belle Classic cars are not fitted with seat belts. Children under the age of three cannot be transported as child restraint devices are not fitted. Carriage of children aged three to five by negotiation prior to the charter.
- Changes to the schedule are communicated to Belle Classic both verbally and by letter or email.**
- Final confirmation of the schedule is given to Belle Classic two weeks prior to the charter or as early as possible before the charter.**
- Overtime rates will be applied per half hour or part there-of at the designated rate. They are due in cash on the day or will be invoiced to the hiring customer.**
Running overtime can be a source of frustration for drivers who may have commitments after your charter, so we recommend that you build some time into your booking schedule for unexpected delays.
- Damage or soiling of the cars** caused by the party (including upholstery damage, spillage and soiling) will be charged to the hiring customer. The cleaning and sanitising fee for soiling is \$200, damage at cost.
- In the event of an unforeseen accident or breakdown** before or during the wedding, we reserve the right to substitute an alternative vehicle to those booked.
- In the event of an unforeseen accident or breakdown** during a charter, Belle Classic will not be held liable for compensation beyond the cost of the car hire for the specific vehicle and time not in service.
